TCEQ 2014 Report Admits to Leaking Landfills

 In Waller County, the fight against the proposed solid waste municipal landfill, proposed to be located near Hempstead and U.S. Hwy. 290, has only just begun. One claim made by Pintail, LLC, was that due to plastic liners, landfills do not leak and are therefore not a hazard to the water supply. However, a recently released TCEQ 2014 report belies that persistent claim. According to the documents, 55 landfills are leaking toxic chemicals into the water supply. Five of those landfills are located in the Houston area. But, wait! Remember the claims by Pintail LLC that the proposed landfill in Waller County will only contain household garbage, not hazardous industrial waste and would therefore be environmentally friendly? And aren't these landfills lined with thick plastic to prevent them from leaking into groundwater? Well, not exactly. According to Steve Hupp, formerly of Harris County Pollution Control, safeguards like liners can tear, and when they do, polluted liquids

can seep into shallow groundwater, as has been confirmed by the recent TCEQ reports. The contaminated water can then move into our bayous, streams and bays. What are the contaminants in household waste? Products that are regularly thrown away in household trash that are possible contaminants, referred to by environmentalists as HHW (household hazardous waste) include: cleaners, light bulbs, fuels, mercury, paints, pesticides, chlorine, wood stains, and varnishes. All of these items can be hazardous if a landfill leaks. Texans need to note that several bills are under consideration by the 84th Texas Legislature that, if passed, would diminish local control and preempt local ordinances in regards to landfills. HB 1247, HB 1865, and SB 709 would reduce the rights of local residents concerning permitting of new polluting facilities. Bills that would benefit those affected by a municipal solid waste landfill or other polluting facility are HB 281 and HB 1284. Both would require TCEQ to consider comments from legislators from affected districts prior to any new or expansion permit is issued. The

bills also prohibit TCEQ from issuing a permit unless approved by resolution of the local governing body. To express concerns or opinions on these bills, Waller County residents may reach State Rep. One remedy for reducing the risk for contaminated groundwater, according to Melanie Scruggs, with Texas Campaign for the Environment, is to recycle. Recycling has been a tough sell in Texas; however, since there's lots of land which makes it cheaper just to bury the garbage. Environmentalists contend that burying garbage may be cheap, but the price of a leaking landfill is insurmountable in its effects on human and animal life. Commissioners Court Approves Intervention in SOAH Hearing

 On Wednesday, April 8, the Waller County Commissioners Court met in regular session at 9 a.m. in the Waller County Courthouse. Commissioners Justin Beckendorff, Jeron Barnett, Russell Klecka, and John Amsler were present and County Judge Trey Duhon presided. In a unanimous vote of solidarity, the court passed a Resolution authorizing the Waller County Commissioners Court to intervene in the State Office of Administrative Hearings (SOAH) in opposition of Pintail Landfill, LLC's application for municipal solid waste permit No. 2377, scheduled to take place this August in Austin. In regards to the Resolution, Commissioner Amsler stated, "It's the right thing to do--to engage in an active, visible display of interest in this fight." Commissioner Beckendorff supported the resolution, but added that passing this resolution was not a "blank check" to the law firm, but only an agreement at this time to file with the state a

petition which would allow Waller County to participate actively with the City of Hempstead and CALH in the SOAH in August. Judge Duhon announced that for the first time, Waller County received the Platinum Member Leadership Circle Award for financial transparency. Waller County is one of only 45 counties (out of 254) that achieved the platinum level. Duhon thanked County Auditor Alan Younts, in recognition of his assistance in gaining the Platinum Level Award, for his addition of the financial transparency tab on the county website. In further business, a presentation was made by J.D. Head of Fritz, Byrne, Head & Harrison, PLLC (Environmental Law) regarding devising a comprehensive waste management plan for Waller County. According to Head, although Health and Safety Code states that each county is to have a waste management plan, such has not been the case because the cost of the plan is to be funded through

Editorial... We're Watching

In last week's edition of The Waller Times, Columnist Carrie Prazak-Gourley reminded the local citizenry of the importance of We the People and what we must expect from our local government officials. This week, she reminds us again that taxpayer-supported entities should be held accountable for their transparency - or lack thereof.

On separate occasions over the past few years, We the People elected out of office some officials we did not trust to handle our local governmental affairs. This is our "power of the pen" so to speak in getting done what we believe is good and just. Elections are held locally at least every two years, and in each election, there are people running for offices at city, school, county, state and federal levels.

We still have some work to do. All of our elected officials are paid for by tax money that comes from We the People. Some officials serve their constituents at no cost to the taxpayer such as City Council members, School Board Trustees, and various other boards that serve the public good. In addition, there are hundreds, if not thousands of government and school employees who are paid their salaries with taxpayer money. Each

of these representatives of taxpayer-supported money should be held accountable by We the People.

As we see every day throughout our society, accountability is rare. Politicians are in the news almost every day performing all kinds of misdeeds and are rarely held accountable, even when the misdeeds are brought to the public light. Locally, it gets more interesting.

Of all of the Waller County governmental entities, only two regularly sends their weekly or monthly agendas to The Waller Times. We do not have to ask for it and it never ceases to show up in advance of their meetings. This should be the practice of every entity that is taxpayer-supported, including the school districts. Because we know what is planned at the meetings, it gives us - and the general public - an advance opportunity to ask questions and try to understand how our tax money is being spent.

No local media outlet has the capacity of covering every meeting, even the Houston "big boys". It just isn't feasible. But when we see something questionable, we should have the opportunity to ask questions and publish our findings, even if it doesn't look good for our community. (This opportunity

Law Enforcement and Public Accountability... What Do Citizens Have a Right to Know?

Law enforcement is vital to the safety of our society, and in Texas the "Thin Blue Line" has always been held in a position of honor and respect.

However, since law enforcement also wields a great deal of power, and is a tax-paying entity entirely supported by citizens, it must be accountable and transparent to the citizens of a community in order to maintain effectiveness.

Governor Greg Abbott released in 2014 a Handbook on Public Information in which he stated, "Our republic was

founded on the principle of self-government--implicit in the idea of self-government is the notion that the public should know what their government is doing."

So what does the public have the right to know in regards to law enforcement documents in Texas?

According to the Reporter's Committee for Freedom of the Press' "Open Government Guide", the following guidelines exist for law enforcement transparency in Texas:

1) Accident reports revealing the date of the accident, the persons involved and its location, along with towing and 911 call records are only available to be released to a petitioner provided the individual knows 2 of 3 pieces of information: date, person, and location.

2) Police "blotter" or "show up sheet" and arrest sheet are not exempt from disclosure. These "arrest sheets" containing an arrestee's name, age, place of arrest, names of arresting officers and offense

for which the subject is arrested are required to be released.

3) Tape recordings of calls made to 911 are public information, even if held by a 911 network district.

The Texas Public Information Act does exempt from release the names of sexual assault victims, names of police informants, and internal law enforcement detection and investigation methods.

One problem related to transparency in law enforcement is that the PIA exempts release of records dealing with law enforcement active investigations as stated in Section 552.108 of the Texas Govt. Code. Under this clause, police departments can withhold information from the public for lengthy periods of time.

Therefore, in a sense, law enforcement has discretion on public records in its possession that may become information in an investigation or prosecution, which can limit the ability of citizens to keep a check on government power.

A new study conducted

by San Diego State University has found that law enforcement agencies that are overseen by a civilian review board are more transparent, especially those affiliated with a national non-profit like the National Association for Civilian Oversight.

As for police incident reports in Waller County, they can be acquired in person at police departments or at the Waller County Sheriff's Office for a nominal fee, by filling out a public information request in person or by fax (for the Sheriff's Office).

Access to this information varies all over the state of Texas. Some police departments and sheriff's departments in Texas have the availability of accessing information such as accident and incident reports online, and some law enforcement agencies post all incident reports on their website. This wide variation in policies makes transparency dependent on the discretion of each department.

Another problem with transparency can occur when a law enforcement agency relies solely on social media such as Facebook or uses their own website to release information about crimes or disasters. This allows departments to tailor the information released to the public, especially since many law enforcement agencies do not release incident reports unless a public information requests it to be filed.

Of course, social media and the internet can be a great addition to public transparency, but should not be used as a sole source of information given to the public by law enforcement and should not replace total media access to information.

A fundamental issue remains. If the public reports a crime, and the police record that information -- the basic who, what, when and where in an offense report that starts the process of investigating, shouldn't that information be available to the public?

Unfortunately, as previously stated, in Texas there is no uniformity to the availability of information. Some cities post all arrest records online,

Senator Kolkhorst Passes First Bills as Senator

Recently, the Texas Senate passed two bills authored by State Senator Lois Kolkhorst, the first legislation for her to pass as a member of the Texas Senate.

In passing Senate Bill 759, Kolkhorst repeals two state taxes. The first tax abolished is currently applied to the rental of premises for conducting bingo, a popular pastime in much of her Senate District 18. The second tax repealed in her bill is regarding liquefied gas (LPG) used to power motor vehicles. By eliminating both of

these taxes, Kolkhorst said that the Texas Comptroller of Public Accounts will now be able to focus resources on more productive areas of the state's tax laws.

"There's a reason the first bill I've passed as a Texas Senator is to cut taxes. Texas is a national leader because we are constantly looking for ways to lower our tax burden. That's why I've worked with our Texas Comptroller Glenn Hegar to craft a bill to eliminate taxes that were not worth the time and effort to collect."

In passing Senate Bill 791, also known as "Maddie's Law," Kolkhorst calls for increased public education and outreach programs to inform women of the risks, symptoms, and treatment of Congenital Cytomegalovirus (CMV). The bill calls for a screening for CMV if an infant does not pass their initial newborn hearing screening. Kolkhorst named the bill "Maddie's Law" based on Maddie Armstrong, who was a Ft. Bend county infant who succumbed to CMV.

"There is a severe lack of

information given to the public on how to prevent CMV and every year more infants die or are permanently disabled from an infection that could have been prevented," said Kolkhorst. "Texas is going to be a national leader in preventing infant deaths and permanent disabilities from a preventable infection like CMV. I am proud to author and pass this legislation on behalf of my constituents who have been touched by CMV."

Texas Senate District 18 includes Waller County.

Senator Lois W. Kolkhorst Passes SB 474 Protecting Landowners' Property Rights

In passing Senate Bill 474, Kolkhorst's legislation will help level the playing field for landowners. This bill requires condemnors to pay the costs and fees incurred by landowners in eminent domain proceedings if the amount of damages awarded to the landowner is at least 20 percent greater than the initial amount the entity offered to pay. This legislation enjoyed broad support

from the Texas and Southwestern Cattle Raisers Association, Texas Farm Bureau, and Texas Wildlife Association, among others.

"Landowners across Texas are often forced to accept low offers for their property in condemnation cases because they can't afford to fight to get fair compensation. If landowners are forced to go through the condemnation process under

current law, they are never really made whole because of the legal fees and appraisal costs they must pay," said Kolkhorst. "Senate Bill 474 protects landowners whose property is taken for public use by strengthening their ability to fight for fair compensation."

Texas Senate District 18 includes all or parts of 21 counties including Waller, Aransas, Austin, Burleson, Calhoun,

Colorado, DeWitt, Fayette, Fort Bend, Goliad, Gonzales, Harris, Jackson, Lavaca, Lee, Matagorda, Nueces, Refugio, Victoria, Washington, and Wharton. Senator Kolkhorst and her husband Jim have been married for 27 years and have two children, Lois Kate and Jake. Senator Kolkhorst had previously served House District 13 in the Texas House of Representatives for 14 years.

Cattle Raisers Praise Passage of Senate Bill 474

The Texas and Southwestern Cattle Raisers Association recently praised passage of Senate Bill 474, which helps landowners receive a fair offer in eminent domain proceedings. Sen. Lois Kolkhorst, (R-Brenham) authored the legislation and it was passed in the Texas State Senate last week with a 25-6 vote.

"I am very pleased this important legislation passed the Senate," said TSCRA President Pete Bonds. "Many times, too often landowners are forced to accept lowball offers in condemnation cases because they can't afford litigation that could help them receive fair compensation for their property. Fortunately, this bill helps level the playing

field for landowners by requiring condemnors to pay the landowner's litigation fees if the initial offer is too low.

SB 474 requires condemnors to pay the attorney and professional fees incurred by landowners if the amount of damages awarded by the special commissioners is at least 20 percent greater than the amount the con-

demnor offered to pay before the proceedings began or if the commissioner's award is appealed and a court awards damages in an amount that is at least 20 percent greater than the amount the condemnor offered to pay before the proceedings began.

"TSCRA appreciates Sen. Kolkhorst for her hard work on this legislation and for always

going to bat for Texas landowners. We encourage legislators in the House to pass this bill so it can be sent to the Governor's desk for his signature," Bonds concluded.

Impaired Driver Campaign Sets Sights on Hispanic Males

Impaired driving continues to be a significant problem in Texas and responding to this challenge requires an effective plan to communicate with all Texans. In 2014, young Hispanic males comprised 49 percent of all statewide male drivers, ages 17-34, involved in impaired driving crashes. These crashes led to 605 serious injuries and 275 deaths, leaving families facing a lifetime of loss. In an effort to reduce crashes and save lives, the Texas Department of Transportation today is launching a bilingual, DUI awareness campaign called "Drink. Drive. Go to Jail. De Veras."

"Unfortunately, drinking and driving remains a serious problem in Texas," said TxDOT Executive Director LtGen Joe Weber, USMC (Ret). "Until that changes, we must be diligent in our efforts to save lives, reduce crashes and spare families the heartache of losing loved ones to irresponsible decision making. The loss and suffering that comes with drinking and driving is entirely preventable. Don't do it. Period."

The "Drink. Drive. Go to Jail. De Veras." campaign runs through May 23 to overlap with Easter, Fiesta and Cinco de Mayo. The Spanish phrase "De Veras," meaning "For Real," is a common expression used by Spanish speakers when responding to expressions of disbelief. Recent census numbers show that 38 percent of the Texas population is Hispanic. This number is expected to grow significantly in the coming decades along with the state's overall population.

Recognizing the importance of this campaign, the Association of Hispanic Municipal Officials and the Texas Association of Mexican American Chambers of Commerce are joining TxDOT as partners.

"As an organization that

cares deeply about the welfare of the Hispanic community, we support this effort and its focus to save the lives of our young Hispanic drivers," said San Marcos Mayor Daniel Guerrero, President of the Association of Hispanic Municipal Officials. "Our young drivers need to be educated on the fact that one wrong decision can

have dire ramifications on their future. This campaign, with its cultural influence, will resonate strongly in the Hispanic community."

of the dangers involved when they drink and drive — hefty fines, jail time or worse, the loss of a life. We are proud to support this campaign for a second year in the continued hope of seeing more lives saved in our community."

Texas Council of Governments, or COGS, which have not funded the plans.

Head stated that regional government entities, such as the Houston-Galveston Area Council, already have a waste management plan in place.

Head added that the only requirement of county governments was to ensure that all citizens have access to solid waste services, and went on to recommend that the

county not pursue a county waste management plan due to its long, arduous, and costly process.

When asked about revamping the 2011 landfill ordinance, Head stated that two counties --Caldwell and Guadalupe County -- are currently in the process of opposing Green Group Holdings (parent Co. of Pintail) in their acquisition of municipal solid waste landfill permits with the help of their local ordinances.

Ordinances can be successful Head acknowledged. As an example of a successful ordinance, Head mentioned Caldwell County's ordinance which prohibits a landfill over a recharge zone. Green Holdings Group recently lost its bid to strike down Caldwell County's ordinance in a hearing.

Commissioners also approved a Proclamation recognizing April as Sexual Assault Awareness Prevention Month in Waller County.



tunity should be available in advance if we truly want complete transparency.) While we generally choose not to publish plenty of public records such as divorces, foreclosures, tax liens, etc., we are responsible as a free press to report on the actions of public officials. As we all saw in the case of Commissioners Court starting in 2011, some things must be looked into and reported on. (Area citizens themselves revealed the controversy of the

Commissioners Court back in 2011.)

So far, no current local media has engaged in a full news program, but The Waller Times is getting there. We are watching and waiting. We are asking questions. We are getting ignored some of the time, but we are patient and willing to work with our officials who are continuing to promise us the information we are requesting. The question is: When is enough, enough? In a small town, pointing fingers and naming names if sometimes uncomfortable, but all of us must remember that elec-

tions are right around the corner and not being forthcoming with public information is not good business.

With the advent of social media, and the many new ways to get instant access to what's going on in the world, we see a new way of thinking emerging from the crowd. The new generations are enjoying this new "information" stream and they feel like they have access to what's going on with anyone, anytime. The problem is - as Prazak-Gourley points out this week -- they are getting only what the originator wants them to know which is not necessarily the truth - or the whole story. Currently, most taxpayer-supported entities are allowing social media to control the dialogue. It's unfortunate, but we can turn the tide.

Law enforcement agencies across the world are creating facebook pages and posting items they think the world wants to see. Does that make them accountable? Do you think they are going to post any information that will shed them in a bad light? No. They will only post something that makes them look good, "work-

ing for you, the taxpayers!" Only a free press, and sometimes the help of an outraged citizenry, can put a dent in making sure our elected leaders are held accountable for spending our money and governing our affairs. Unfortunately for them, when they do get caught up in a scandal, social media is up and running again, even before they have had a chance to defend themselves.

With all of this said, We the People need to take control of our community and keep our elected and unelected officials on their toes.

I agree with Carrie Prazak-Gourley. The new Waller County Commissioners Court is a breath of fresh air. Kudos to them for their quick turnaround in Waller County and to the citizens that held them and their former colleagues accountable. The court can be divided in its opinions; that is part of the American democracy. What it can't be is closed off to the people and the press.

Let's hope the rest of the stewards of the public trust can be equally transparent. We are watching....and waiting. Stay tuned.





while others do not. When it comes to the release of police information, it's police departments themselves who determine what incidents are released to the press. And that can be a problem in regards to transparency.

For decades, open records have helped the public obtain government records as a means to watch over taxpayer funded agencies.

According to the Texas Press Association, a 1976 challenge by the Houston Chronicle set the standard for what should be clearly public: "Basic information that ordinarily appears on the first page of an offense report."

Ultimately for the citizen,

there is no way to know who may be involved or what has happened unless we receive all the information that the law allows, and in a timely manner. Whether it is a burglary, a violent crime, or a simple trespassing incident, citizens should be informed of what's happening in the community when it comes to crime. Such information could help citizens remain safer and be on guard for certain crimes in their neighborhood.

As previously stated, some cities are more transparent than others. Abilene, for instance, releases incident reports daily, and has them available at the department's front desk. Anyone can sift through

the reports.

Other police departments post daily incident reports online, listing a case number and other information for every call.

To help aid transparency, the Texas legislature has put forth three bills which would require officers to wear a body camera as a further aid to law enforcement transparency. In addition, another bill, HB 474, if passed, would make camera recordings public information subject to release.

Governor Greg Abbott is in favor of body cameras for police officers and stated, "Equipping officers with body cameras is a step in the right direction."

Other bills have been filed to require law enforcement to record suspects while interrogated during custody.

Currently, private colleges and universities are not subject to the Texas Public Information Act, but SB 308, if passed, would require these entities to follow all TPIA guidelines.

Great advancements have been made in transparency, but the fight is not over. Suspects or arrestees are innocent until proven guilty and police body cameras would provide protection for both the officers and the suspects.

To further transparency, incident reports, and all information considered to be in the public domain, should be vol-

untarily released to local media on a regular basis.

So let's continue to bring in the sunshine to all government entities in Waller County, including law enforcement. The people have a right to know what crimes are being committed in their neighborhood in a timely fashion.

Police officers have a tough job and deserve our respect and support. They are the firewall between the community and the criminal, and undoubtedly keep us safe. Their work in keeping our communities' crime rates low is greatly appreciated.

But, as a government agency of "We the People", they must keep the public in-

formed about their activities because unfortunately, sometimes actions left unseen become acts of power rather than acts of justice.
